

**Dr. NTR UNIVERSITY OF HEALTH SCIENCES: A.P: VIJAYAWADA-520 008**

**TERMS AND CONDITIONS GOVERNING THE INSTITUTION OF  
GOLD MEDALS UNDER Dr.NTR UHS**

As per Dr.NTR University of Health Sciences A.P, Act, the Executive Council of the University is only empowered to decide on accepting the gold medals on behalf of Dr.NTR University of Health Sciences, Vijayawada, AP.

The minimum prescribed amount for the institution of gold medal is Rs.5,00,000/- (Rupees five lakhs only).

1. The Donor should pay the amount to this University in the form of a Demand Draft in favour of "The Registrar, Dr. NTR University of Health Sciences, A.P., Vijayawada" for instituting the gold medal. This amount will be the Corpus Fund for the Gold Medal.
2. The Donor should pay the amount to the University as stated above on or before 1<sup>st</sup> of January of any year so that the Gold medal can be awarded to the eligible student(s) during the University Convocation Day of the succeeding year.
3. The Corpus Fund will be invested in Fixed Deposits in any Nationalized Bank to yield higher rates of interest.
4. 20% of the accruing interest will be added to Corpus Fund every year to meet the escalating costs. Only 80% of accruing interest will be utilized for the award of Gold Medal.
5. The Gold Medal will be awarded every year from the interest accruing during that year to an eligible student. If eligible student is not available during that year, the interest will be added to the Corpus fund.
6. The Donor should mention the name of the Gold Medal in his / her application. He /She should also mention the purpose for which he/she is paying the amount.
7. Based on the purpose for which the Gold Medal is requested to be instituted, the University will take a decision the mode of selection of the student(s) for the award.
8. If more than one Donor creates an Gold Medal for the same purpose, the interest obtained from such different funds will be added together. The Gold Medal will be awarded from the total interest to the eligible students.
9. The Executive Council of Dr.NTR UHS has powers not to award the Gold Medal in any year, if in their opinion, none of the students deserve the Gold medal.
10. In the event of the Gold medal not being awarded in any year, the unspent interest shall be added to the Corpus Fund.
11. The Donor will be informed of the name(s) of the gold medal winner(s) and he /she will also be invited to the University's Convocation every year.
12. The Executive Council shall have the powers consistent with the spirit of the endowments to make such changes in the terms and conditions as any circumstances may render necessary.
13. If the Donor is a staff member of Dr.NTR UHS he / she cannot create an Endowment on his / her name during the entire service period.
14. The beneficiaries of Dr.NTR UHS on commercial transactions etc, cannot create an Endowment under Dr.NTR UHS.
15. The University accepts Endowment Medals only if the Donor wishes to institute them for awarding to the meritorious students covering all the affiliated colleges to the University.

16. The University does not accept any Endowment Medal that is already existing under this University.
17. The University does not accept any Endowment Medal, if the Donor desires to institute for a specific college or colleges in a specific region. In such a case, the Donor may approach the concerned Principal of the specific college or the Principals of the colleges under the desired Region for institution of the medal.
