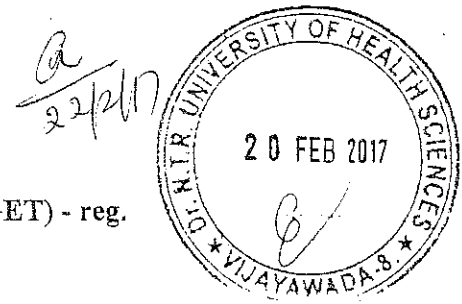

Sir/Madam,

In order to maintain uniformity for admissions in PG courses in AYUSH systems of medicine, a decision has been taken that the All India Institute of Ayurveda (AIIA), Sarita Vihar, New Delhi will conduct an all India level common entrance test namely AYUSH National Post Graduate Entrance Test (AYUSH NPGET) for admission in all AYUSH PG courses from the session 2017-18. The entrance exams being conducted by the private association may be stopped from the academic session 2017-18 and all PG seats shall be filled through AYUSH NPGET in the country.

2. In view of above, all State Governments are required to ensure compliance of the decision of the Ministry and accordingly admit students in AYUSH Post Graduate courses through AYUSH NPGET only. It is further informed that there shall be no management/NRI quota.
3. This issues with the approval of competent authority.
