NOTIFICATION FOR 2nd MOP UP ROUND COUNSELING

Notification for exercising web options for 2nd MOP-UP Round counseling for vacant seats in BDS Course under Competent Authority Quota after 1st MOP-UP Round of Counseling in Government, Private unaided Non-Minority Dental Colleges affiliated to Dr.NTR UHS, Vijayawada in the State of Andhra Pradesh.

In continuation of earlier notifications dated 19.06.2018, 25.06.2018, 26.06.2018 17.08.2018, 24.08.2018 and 28.08.2018 the University hereby notify the 2nd MOP-UP Round of web based counseling for the vacancies available in BDS course under Competent Authority Quota in Government, Private Un-aided Non-Minority Dental colleges affiliated to the University for the academic year 2018-19.

All the eligible candidates who have got verified their certificates can exercise their options from 8.00 AM on 04-09-2018 upto 1.00 PM on 05-09-2018 at <https://apmedadm.apntruhs.in/>.

ELIGIBILITY FOR 2nd MOPUP ROUND COUNSELING:

1. The candidates who are present in the merit list for Competent Authority Quota seats which displayed on 02-07-2018 and not allotted BDS seat under Competent Authority Quota in earlier Phases of counseling are eligible for opting seats in 2nd MOP-UP Round web based counseling.

THE FOLLOWING CANDIDATES ARE NOT ELIGIBLE FOR 2nd MOP UP ROUND COUNSELING

1. The candidates who were allotted BDS seats in earlier phases of Competent Authority Quota Counselings are not eligible.
2. The candidates who were admitted in the BDS course in All India Quota /Deemed Universities etc., conducted by the DGHS, New Delhi are not eligible.
3. The candidates who were admitted in BDS Course in other state counselings including Telangana State are not eligible.

The candidates who have taken BDS seat in the 2nd MOP-UP Round web based counseling will not be permitted to cancel their selection/ seat.

No candidate will be permitted to cancel the seat/ withdraw from the BDS course after this 2nd MOP-UP Round Counseling.

The candidates who were admitted in BDS Course under AIQ/ Deemed Universities etc., Counseling conducted by DGHS, New Delhi/ in other state counselings including Telangana State are not eligible to participate in the 2nd MOP-UP Round Counseling. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.

The seat allocation will be done as per the procedure given in G.O.P.No.646, Education (w) Department, dated 10.07.1979 as amended in G.O.Ms.No.42, Higher Education Department, dated 18.05.2009.

University Fee: The selected candidates have to pay University fee **Rs.9,700/-** through payment Gateway by using Online payment method. (Debit Card / Credit Card / Internet Banking) in the state of Andhra Pradesh for downloading the allotment order.

Tuition Fee: **Rs.11,576/-** as per G.O.Ms.No.30 & 31, HM & FW., (C1) Department, dated 17.04.2015 of the Government of AP for Government, Private Un-aided Non-Minority Dental Colleges.

Instructions to the Candidates:

1. The candidates can exercise web options through <http://apmedadm.apntruhs.in/> using Internet explorer 11 version
2. The candidates who have not exercised web options in previous phases are also eligible to exercise web options.
3. Candidates are not permitted to discontinue the course after 2nd MOP-UP Round Counseling notification is issued i.e., on 01.09.2018. The Candidates already joined in colleges under Dr.KNR UHS and who are continuing in the course under Competent Authority Quota are here by informed that they are not eligible for 2nd MOP-UP Round counseling for BDS Course in order to prevent dual blocking, seats wastage and seat blocking.
4. One Time Password will be sent to the registered mobile at the time of saving Web options.
The password consists of Six letter code with English capitals A to Z.
5. Candidates are instructed to take a printout of saved options
6. Candidates will receive the message on their registered mobile after allotment of seat, if allotted.
7. Candidates have to download the allotment letter by paying the University fee by gateway method (as detailed in the earlier notification dated 25.06.2018).
8. Candidates have to take printout of allotment order, check their allotment and report to the Principal of respective college before the date specified on the allotment letter.
9. The University fee and other fees once paid shall not be refunded under any circumstances.
