1st Phase of Counseling for Admission into MBBS and BDS courses 2018-19 for the seats available under Management Quota in the State of Andhra Pradesh.

The qualified and eligible candidates figured in the **Final Merit Position list** of candidates applied for Management Quota Seats to be displayed on 03.07.2018 are informed that the 1st Phase of Counseling for admission into MBBS / BDS Courses available under Management Quota in Private Un – Aided Non – Minority, Private Un-aided Minority Medical and Dental Colleges (under Dr. NTR UHS) and NRI Quota Seats in Sri Padmavati Medical College for Women (under SVIMS), Tirupati in the State of Andhra Pradesh will be held as per the schedule given below.

- 1. Counseling Fee:** The Candidates attending the Counseling shall pay non-refundable Counseling Fee of Rs. 6,000/- (Rupees Six thousand only) in the form of crossed Demand Draft drawn on any Nationalized Bank in favour of “Registrar, Dr. NTR University of Health Sciences” payable at Vijayawada.

The candidates have to pay the following University Fee and Tuition Fee **immediately after opting the seat on the day of counseling at the counseling centre.** In case of non-payment of Fee the selected seat will be cancelled and will be allotted to the next candidate as per merit. Hence, candidates are informed to attend for the counseling with the DDs’ of University Fee and Tuition Fee without fail.

- 2. University Fee:** The selected candidates shall pay non – refundable University fee in respect Category-B & C seats in Private Un-aided Non-Minority & Minority Medical and Dental Colleges and NRI Quota Seat in Sri Padmavati Medical College for Women (under SVIMS), Tirupati in the form of crossed Demand Draft drawn in favour of “The Registrar, Dr. NTR University of Health Sciences” payable at Vijayawada as given below:

Note: Candidates willing to opt **both MBBS / BDS Seat in Category - B** are informed to bring the University Fee in the form of 2 Demand Drafts i.e. 1. For Rs. 16,000/- and 2. For Rs. 9,000/-

Note: Candidates willing to opt **both MBBS / BDS Seat in Category - C** are informed to bring the remaining balance of University Fee of above category-B seats in the form of Demand Draft i.e., Rs.40,500/- for MBBS and Rs.15,000/- for BDS.

3. Tuition Fee:

As per G.O.Ms.No.30 & 31 HM & FW. (C1) Dept. dt.17-04-2015, the following is the tuition fee in respect of the Category-B & C seats in Pvt. Un-aided Non-Minority and Minority Medical/Dental Colleges.

Note 1: The Fee for Management Quota **Category -'C' (NRI)** for **ASRAMS, Eluru and Apollo Institute of Medical Sciences, Chittoor** is Rs.35,00,000/- P.A.

Note 2: The Fee for Management Quota **Category -'C' (NRI)** for **NRI Medical College, Chinakakani, Guntur Dist.** is Rs.39,99,996/- P.A.

The Tuition Fee has to be paid in the form of crossed Demand Draft drawn on any Nationalized Bank in favour of **“The Secretary, APMDCMA”** payable at Vijayawada on the day of Counseling.

Note 3: The candidates selected for NRI seat in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati have to pay the tuition fee at the college at the time of admission. Visit SVIMS Website: <http://svimstpt.ap.nic.in> for details of tuition fee and other fee particulars.

Note 4: The candidates selected against Management Quota Category-C (NRI Quota) Seats shall pay the fee fixed for management Quota Category-B seat on the day of Counseling and the remaining balance amount of Tuition Fee shall be paid to the Principal of the respective college on the day of admission to the college.

Note 5: Candidates willing to opt both MBBS / BDS are informed to bring the Tuition Fee in the form of 2 Demand Drafts i.e. 1. For Rs. 3,00,000/- and 2. For Rs. 9,73,388/-.

The candidates are informed to pay the remaining balance amount of tuition fee for MBBS course under C category and for BDS Course Under B & C Category at the respective college on the day of admission.

The Tuition Fee has to be paid in the form of crossed Demand Draft drawn on any Nationalized Bank in favour of **“The Secretary, APMDCMA”** payable at Vijayawada on the day of Counseling.

Note 6: Candidates are informed that they have to pay the college fee and university fee on the day of selection/counseling itself. If the candidate fails to pay the fee after choosing the seat, the seat will be cancelled automatically without any notice. The candidates will not be given any extension of time to pay the fee.

4. The selected candidates shall submit one year bank guarantee at the College.

5. PENAL ACTION:

1. If a candidate after admission into a College seeks withdrawal from the course on having obtained a seat under Competent Authority Quota in the AP State, an amount of Rs. 10,000/- will be deducted as processing fee.

2. If a candidate seeks withdrawal from the Course before 2nd counseling of Management Quota Seats, the tuition fee will be refunded after deducting an amount of Rs.1,00,000/- for MBBS Category-B, Rs.2,00,000/- for MBBS Category-C and Rs.50,000/- for BDS Category B & C seat.

3. If a selected candidate in 1st counseling wants to cancel his/her selection, before reporting in the college, he / she shall apply in writing to the University within the stipulated time specified in the allotment order. In case reported in the college, his /her withdrawal letter should reach the University through the Principal of concerned college before 2nd Counseling.

4. If the candidate seeks to withdraw from the course before Mop-up counseling for Management Quota Seats, an amount of 10% of the tuition fee fixed for that category of seat will be deducted as processing fee.

5. After MOP-UP counseling, the candidates will not be permitted to cancel selection/seat.

Certificates to be produced:

The candidates are informed to attend to the counseling in person with one parent/guardian. Custodian certificate of the Colleges affiliated to Dr NTRUHS, Vijayawada only will be considered. **The custodian certificates issued by the Colleges which are not affiliated to this University will not be accepted under any circumstances.**

- 1 Printout of application form for Management Quota Seats affixing pass port size photo (similar to the photo submitted for NEET examination) and signature at the space provided.
- 2 Admit card of NEET UG - 2018
- 3 Rank card of NEET UG-2018
- 4 SSC or equivalent examination containing the Date of Birth
- 5 Memorandum of marks of qualifying examination i.e., Intermediate or Equivalent examination (10+2).
- 6 Aadhar Card / Pass port in case of NRI candidate.
- 7 Permanent Caste Certificate, if applicable to determine eligibility of cut off marks.
- 8 Minority Certificate issued by the Minority Welfare Department/ concerned authority, if applicable.
- 9 Differently abled (PH) Certificate, if applicable.
- 10 Undertaking on WHITE PAPER signed by both the candidate and the parent/guardian. (Proforma of undertaking is available on the University Website)
- 11 Declaration (given at Annexure-II in the Prospectus) **on White Paper signed by both the candidate and NRI** alongwith evidential documents such as Green Card/Citizenship Card/Bank Statements/Pass-port issued by the respective Country/Electricity Bill/Gas Bill /Water Bill . (Visa / Driving license will not be accepted) if candidates opting for Management Quota Category C (NRI Quota) Seats in Un-aided Non-Minority, Minority Medical and Dental Colleges.
In addition to the above, proof of AP origin is to be produced in case of opting seat in NRI Quota seats in Sri Padmavathi Medical College for Women (under SVIMS), Tirupati.
