5. Fees once paid will not be refunded under any circumstances.
6. All payments shall be made in favour of the Registrar, Dr. NTR UHS, Vijayawada payable at Vijayawada from Nationalized Bank.
7. Duly filled in application form and attested documents will only be considered. (Incomplete applications will be rejected).
8. Should not enclose any other copies which are not asked for.
