NOTIFICATION FOR 1st PHASE OF WEB COUNSELING FOR ADMISSION INTO THE STATE QUOTA SEATS OF POST-GRADUATE MEDICAL DEGREE / DIPLOMA COURSES UNDER Dr.NTR UHS & PG MEDICAL COURSES AVAILABLE IN SVIMS, TIRUPATI FOR THE ACADEMIC YEAR 2019-20, UNDER COMPETENT AUTHORITY.

In continuation of earlier notifications dated 22-03-2019 and 31-03-2019, the University hereby notifies the schedule for the 1st phase of Web counselling to fill up the State Quota seats of PG Medical Degree/Diploma courses under Dr.NTR UHS and SVIMS, Tirupati for the academic year 2019-20, under Competent Authority:

All the candidates (Service & Non-service including PH) whose names are in the Merit Position notified on 05-04-2019 in the University Website are only eligible to exercise web options on the above scheduled dates as per the seat matrix displayed in the website <http://ntruhs.ap.nic.in> .

UNIVERSITY FEE: Candidates to whom allotment message is given have to pay Rs. 23,500/- before obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card/Credit Card/Internet Banking).

TUITION FEE: The following is the **Tuition fee structure** to be payable for the Competent Authority Quota seats in Private Un-aided Non-minority Medical Colleges as per GO.MS.No.72, HM & FW (C1) Department, dated 03-05-2017 of Government of Andhra Pradesh :

The above mentioned fee particulars are as per GO.MS.No.72, HM & FW (C1) Department, dated 03-05-2017 of Government of Andhra Pradesh, however the fee to be collected from the selected candidates shall be as per the interim directions of the Hon'ble High Court in WP Nos. 130, 131 & 132 of 2017 and WP No. 17102 of 2017 subject to outcome of Writ Petitions.

Instructions to Candidates:

1. Candidate can give options on the web either from home or any other place having internet facility
One Time Password will be sent to the registered mobile at the time of saving Web options.
The password consists of SIX letter code with English capitals A to Z.
2. The detailed instructions for entering options on web are available at <http://appgmed.apntruhs.in>
3. **Candidate can download the provisional allotment order on payment of University Registration Fee through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order.**
4. Area wise seat matrix will be displayed in the Website for the information of the students to exercise their option. **A candidate can exercise any number of options.**
5. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
6. Candidates are informed to check their final allotment, take printout of allotment letter from the web, and report to the respective colleges on or before the date furnished on the allotment letter, failing which the candidate will lose the admission.
7. Next rounds of counseling (exercising web options) will be conducted for:
 - a. Unfilled seats in phase-I
 - b. Not reported / Not joined seats.
8. Selected candidates have to report at the respective colleges on the dates specified on the allotment letter with all original certificates, submit the bonds and pay the college fee to complete the admission process. If the candidate slides to other college during subsequent phases of counseling, the original certificates will be sent to the college concerned after the closure of admissions.
9. The University fee and other fee once paid shall not be refunded under any circumstances.
