MBBS ADMISSIONS - 2020-21 – COMPETENT AUTHORITY QUOTA SEATS EXTENDED FINAL PHASE WEB BASED COUNSELING

1. The candidates who are present in the Provisional Final Merit Position list displayed in the website on 07.12.2020 are hereby informed that the seats vacant due to non-joining of candidates allotted in the 3rd & final phase counseling and cancellation of seats are available for Extended Final phase of counseling scheduled on **27.12.2020**.
2. The candidates who have joined the MBBS course seat in All India Quota / Deemed Universities and candidates admitted in the colleges affiliated to KNR UHS and continuing after free exit (Phase – 2) are not eligible.
3. The selections will be made strictly as per the G.O.Rt.No.550, dated.30.07.2001 as amended vide G.O.Rt.No.111, dated.13.08.2019 and G.O.Rt.No.159, Higher Education (E.C) Department, Dated.13.11.2020.
4. The candidates who have joined in the allotted college and also the candidates who have not been allotted MBBS seat will be considered for the available vacancies in the extended final phase of counselling for upgradation / sliding to other college basing on the **ONE TIME OPTIONS ALREADY EXERCISED BY THE CANDIDATES**. Seats vacated by candidates sliding during this phase of counseling will be added and allotted simultaneously during this phase of counseling. The existing seat will be cancelled automatically on allotment of a seat in this extended final phase of counseling as per his/her option.
5. If a candidate is allotted a seat in MBBS course as per his/her options and does not join the course he/she will not be eligible for that course in Mop-up phase of counseling to prevent seat blocking.
6. The mop-up counseling will be conducted for the vacancies due to non-joining of candidates allotted seats in the extended final phase counseling. The candidates who were allotted seats in the Phase-I, Phase-II (revised), 3rd & final and extended final phase counselings (both reported and not reported candidates) are not eligible.
7. Candidates will receive the message on their registered mobile after allotment of seat, if seat is allotted. The candidates also instructed to visit the website:<https://apmedadm.apntruhs.in> for status of allotment.
8. Candidate can download the provisional allotment order on payment of University Fee Rs.10,500/- through payment gateway. The students can login and view the college wise list of selected candidates in the website. Candidates who have paid university fee in the first, second and 3rd & final phase need not pay again.

9. Candidates are informed to check their final allotment on website and take the printout of allotment letter from the web and report to the respective colleges on or before the date specified on the Provisional allotment letter.
10. Candidate who was already joined and slide to another college is deemed to be relieved from the previous college and report to the Principal of now allotted college with
 - a. Allotment letter of extended final phase counseling (P4)
 - b. Custodian certificate issued by the previous college
 - c. Admission letter issued by the previous admitted college affiliated to Dr. NTR UHS
 - d. Pay the tuition fee to complete the admission process, failing which the candidate will lose the admission. The candidate also informed to intimate the Principal of earlier college about the allotment of seat in extended final phase counseling.
11. Candidates who are allotted seat in the extended final phase have to report to the allotted college with all original certificates, provisional allotment order and provisional verification copy and pay the tuition fee and college fee.
12. The original certificates will be verified at the college and in case of any discrepancy the provisional allotment will be cancelled and action will be initiated as per University regulations.
13. If the candidate slides to other college during extended final phase of counselling, the original certificates will be sent to the college concerned after the closure of admissions. Original certificates will not be returned to be candidate, unless the candidate discontinues the course.
14. The University fee once paid shall not be refunded under any circumstances.
15. **No candidate is permitted to withdraw from the course till closure of the admissions.**
16. If any candidate wants cancel the MBBS seat in the middle of the course or after closure of admission he/she has to pay penalty of Rs.3,00,000/- plus GST @ 18% applicable as per orders of Government of AP.
