Admission into M.Sc., (Nursing) and MPT Courses Under Competent Authority Quota for the academic year 2020-21 in the State of A.P.

Inviting Online application forms and Uploading of scanned documents for Verification

Online application forms for admission into M.Sc., (Nursing) courses and MPT courses for the academic year 2020-21 in the colleges affiliated to Dr. NTR University of Health Sciences, Vijayawada are invited from the eligible candidates.

The candidate has to apply separate application forms for each course as per their eligibility as detailed below:

1. M.Sc., (Nursing) courses
2. Master of Physiotherapy i.e., MPT courses

1. Eligibility for M.Sc.,(Nursing) Courses

The Candidates should be Indian National and should satisfy Local or Non-Local status as per G.O.P. 646, Education Dept., dated 10-07-1979 and must satisfy the eligibility criteria as below:

S.No	Eligibility Status
a) Age:	Both the Service and Non-service candidates should not have completed 45 years of age as on 31-12-2020. For candidates belonging to SC and ST's the maximum age limit shall be 48 years.
b) Sex:	Both women and men candidates are eligible to apply for the M.Sc., (Nursing) as per G.O.Ms. No. 77, HM & FW (K1) Dept, dated 13.06.2013. Regarding male candidate, admission will be as per G.O.Ms.No.79, HM & FW (K1) Dept, dated 17.06.2013.
c) Educational Qualification:	The candidate should have passed B.Sc., (Nursing) /B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) from an Institution which is recognized by the Indian Nursing Council with minimum of 55% aggregate marks and 5% relaxation of marks for SC and ST candidates
d) Merit list:	<ol style="list-style-type: none">a. There is no entrance test for admission into M.Sc., (N) courseb. The selection of Candidate will be made by the selection committee as per the merit list.c. The merit list will be prepared basing on the marks obtained in B.Sc., (N)/ B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) group subjects (all subjects) excluding computer sciences and English marks up to two decimal places.

- d. **As the Merit list will be prepared basing on Group subjects, the candidates while filling up of Online application, shall enter the total marks excluding English marks & Computer Science Marks as the case may be.**
- e. In case of equality aggregate marks, age shall be taken into consideration and older candidates shall be given higher places in the merit list.
- e) Registration with Nursing Council: Candidate should be a Registered Nurse and Registered Midwife of Indian Nursing Council for Service and Non--Service candidates.
- In case of B.Sc., (N) candidates, those who registered in Nursing council prior to 31.01.2020 are only eligible. Those who registered after 31.01.2020 are not eligible for this admission year 2020-21.
 - In case of Post B.Sc., (N) candidates those who registered in Nursing council prior to 31.01.2021 are only eligible. Those who registered after 31.01.2021 are not eligible for this admission year 2020-21.
- f) **Experience:**
1. For Service Candidates: Should be a regular employee of the Government of AP/Telangana as per the para 12 of AP Education Institutes (Regulations of Admissions) order 1974 (AP Medical & Health Services and AP Vaidya Vidhana Parishad / Telangana Vaidya Vidhana Parishad) and should have put in not less than 5 years of Service in the said Dept., in any capacity in Nursing as on **31-01-2021**.
2. For Regular Candidates (Non - Service candidates):
- a) Minimum one year of work experience after Registration of B.Sc.,(Nsg.) Degree in Nursing council as on **31-01-2021 is required**. That means the candidates who registered in Nursing council as on 31.01.2020 are only eligible and those who registered in Nursing council after 31.01.2020 are not eligible as they will not complete one year experience by 31.01.2021.
- b) Minimum one year of work experience prior to Registration of Post Basic B.Sc., (Nursing) courses as on **31-01-2021**.
- Note:** Experience Certificate once submitted is final. No alterations/ no revised service certificate will be accepted after submission of application. The candidates who have not acquired relevant service and not submitted requisite service certificate, such applications will be rejected and no further correspondence will be entertained. Therefore, candidates are advised to check the application before submitting.
- g) Physical fitness : The candidate shall be medically fit.
- h) i. The candidates who qualified Post Basic B.Sc., (Nursing) from IGNOU through distance education are also eligible, if the study center is recognized by Indian Nursing Council.
- ii. The candidates, who completed Post Basic B.Sc., (Nursing) from any IGNOU study centers can make application for admission into M.Sc., (N) course provided they have taken admission in IGNOU study centers prior to year 2012. The students who have undergone P.B.B.Sc(N) course from IGNOU after this date are eligible for admission into M.Sc.(N) only if the study centers are recognized by IGNOU.

2. Procedure of filling online application form and payment of fee through online:

- a. The fee paid by the applicants is not refundable under any circumstances.
- b. Read the Notification, Prospectus / Regulations carefully regarding eligibility under local and non-local.
- c. Visit website through Internet Explorer 11 version only to fill the application form.
- d. The Registration number which will be sent to the registered mobile after entering the basic details, should be noted for further use. The Registration number should be kept confidential and should not be disclosed to others.
- e. Fill - in all the correct details in the online application form and upload all the documents including the certificates which are mandatory.
- f. The following Certificates are required to complete the online application process. The certificates are to be scanned and kept ready to upload. Application fee has to be paid through online.

3. Eligibility for MPT Courses

Candidates who passed B.P.T. degree of Dr. NTR University of Health Sciences or equivalent Degree, and have completed internship on or before 31-01-2021, are eligible to apply subject to fulfillment of the conditions stipulated in these Regulations.

5. Verification fee: The candidates who studied B.Sc., (Nursing) and BPT respectively outside the state of Andhra Pradesh / Telangana (other than Dr. NTRUHS) are required to pay **Rs.1,180/-** towards Degree Verification fee in addition to the above registration fee.

Note:- Application and Counseling Fee once paid will not be refunded Under any circumstances.

6. Instructions to the candidates: -

- a. The process of admissions into M.Sc., (N) Courses will be in accordance with the orders issued by Govt. of A.P. vide G.O.Ms.No.338, HM&FW (K2) Dept., dt.16.09.2008, G.O.Ms.No.33, HM&FW(C2) Dept., dt.18-02-2020 and other rules as applicable to PG Medical and Dental courses.
- b. The process of admissions into MPT Courses will be in accordance with the orders issued by Govt. of A.P. vide G.O.Ms.No.63, HM&FW (K2) Dept., dt.23.02.200 and other rules as applicable to PG Medical and Dental courses.
- c. Any orders that may be issued from time to time by University, Govt. of A.P. and INC, New Delhi and other rules as applicable to PG Medical and Dental courses.
- d. The candidates are advised to download and read the Prospectus of the course and instructions for filling Online Application available in the University Website <http://ntruhs.ap.nic.in> before filling the online Application.
- e. Same application will be considered for all phases of the counseling.
- f. Due to Covid-19 and Pandemic conditions, the certificates verification will be conducted basing on the uploaded scanned certificates. No separate notification will be given for verification of Original certificates. The candidates claiming reservation under PwD category are advised to watch the University website for further notifications.
- g. The merit list will be prepared basing on the marks obtained in B.Sc., (N)/ B.Sc., Hons (Nursing)/Post Basic B.Sc., (Nursing) group subjects (all subjects) excluding computer sciences and English marks up to two decimal places.
- h. As the Merit list will be prepared basing on Group subjects, the candidates while filling up of Online application, shall enter the total marks excluding English marks & Computer Science Marks as the case may be.**
- i. Hence, the candidates should register and upload all the mandatory certificates without fail and verify once again before submission of online application.
- j. Scrutiny of uploaded data will be done by the University and officials from the concerned Departments. After scrutiny of scanned certificates, provisional merit list will be released and final merit list will be released later.

k. The On-line application form with the following lacunae will be rejected automatically. No communication will be sent in this regard.

- a. If any of the mandatory certificates are not uploaded.
- b. Applications with incomplete details / photo and signature.
- c. If any of the uploaded certificates are invisible/not properly uploaded.
- d. If the certificates are not properly scanned due to which the eligibility criteria cannot be determined.

k. The candidate seeking the benefit of reservation under PH category, should present him/herself before Medical Board to be constituted by Dr.NTR UHS.

l. The candidate should submit the Printout of the filled in Online application form, Provisional verification form and all Original certificates along with One set of self attested copies to the Principal of allotted college at the time of joining for final verification. In case of any discrepancy, the Provisional allotment order will be cancelled without any notice. The candidates are informed not to send the print out of application form to the University.

7. Candidates admission is strictly provisional. The mere fact that the Merit position issued to him /her does not imply that his/her candidature is accepted by the University and it does not mean that the entries made by him / her in the online application are accepted as true and correct. An in-eligible candidate obtaining Merit position does not make him/her eligible for admission.
8. The candidates eligibility for admission into M.Sc., (N) courses and MPT Courses for the academic year 2020-21 will be examined by the University officials and officials of the concerned department only basing on the uploaded scanned original certificates.
9. If the information furnished by candidate in the application is incorrect, his/her candidature is liable to be cancelled and further action that deems fit will be taken. If the certificates produced by any candidate are found to be fake / false/forged at any stage of verification or admission, the University has every right to cancel the seat / admission of such candidate without any notice. In case of discrepancy in the downloaded provisional verification form, the same shall be brought to the notice of the University immediately.
10. Candidates are informed that final verification of original certificates will be conducted at the college of admission and in case of any discrepancy, the provisional allotment will be cancelled and action may be initiated as per University Regulations.
11. Subsequent notifications with regard to web counseling will be notified on the University website only. Visit the University website <http://ntruhs.ap.nic.in> regularly for subsequent notifications / instructions till the completion of admission process.
