**Applications are invited through online for the MOPUP Round Counseling and also for stray vacancies, if any, in MBBS/BDS Courses – 2019 under **Management Quota** in the State of Andhra Pradesh.**

Application forms through online are invited afresh from the eligible candidates who secured the cutoff scores in NEET UG 2019 and who have not applied earlier as per the schedule given below for the vacant Management Quota seats in MBBS/BDS Courses in the Private Un-aided Non-Minority/Minority Medical and Dental Colleges in the website <https://appvtmedadm.apntruhs.in/>

Online counseling will be conducted for the MOPUP round for the MBBS seats **at Dr.NTR University of Health Sciences, Vijayawada** on **29-8-2019**. The candidates should present to the counseling in-person along with Original Certificates and University Fee as per the schedule which will be notified and displayed on the website separately. Selected candidates have to deposit their original certificates and pay university fee immediately after opting the seat.

No. of available vacancies will be displayed in the University website on 28-08-2019.

The candidates who are figured in the merit list of Management Quota and not opted for Category C seats (NRI) seats while filling online applications earlier, such candidates can attend for MBBS Mopup Round counseling along with NRI Declaration and NRI's evidential documents for opting Category C (NRI) seats.

**ELIGIBILITY FOR MBBS MOPUP ROUND COUNSELING:**

1. The candidate who are present in the merit list for Management Quota seats which displayed on Website and not allotted MBBS seat under Management Quota in earlier Phases of counseling are eligible for attending in the MOP-UP Round Counseling. They need not apply now.
2. The Candidates whose names are present in the merit list for management Quota seats and not exercised web options in earlier phases of counseling are eligible.

**THE FOLLOWING CANDIDATES ARE NOT ELIGIBLE FOR THE MOPUP ROUND COUNSELING**

1. The candidates who were allotted MBBS seats in earlier phases of Management Quota Counseling and also admitted in the MBBS course in AIQ /Deemed Universities etc., conducted by the DGHS, New Delhi / other state counseling including Telangana are not eligible to apply.

The candidates who have taken a seat in the MOP-UP Round counseling of Management Quota will not be permitted to cancel their selection/ seat.

If any candidate admitted in MBBS course under Management Quota wants to withdraw/cancel the MBBS seat after reporting and before 2.00 PM on 28-8-2019 for Management Quota seats, such candidate's request should be forwarded to the University. On receipt of reply from the University the Original Certificates and Tuition Fee should be refunded to the candidate without any deductions. **Those candidates will not be permitted again to participate in further round of management quota counseling including admission into stray vacancies.**

No candidate will be permitted to cancel the seat/ withdraw from the MBBS course after MOP-UP Round Counseling.

Stray vacancies, if any, after MOP-UP Round Counseling will be filled with the candidates in the Management Quota Merit List and not allotted MBBS Seat any where.

1	<p><b>Registration Fee:-</b> The candidates have to bring the D.D. towards Registration fee of <b>Rs.3540/-</b> drawn in favour of the Registrar, Dr.NTR UHS, payable at Vijayawada while attending for the counseling. Further, the candidates who have registered earlier need not pay the registration fee again.</p> <p><b>Counseling fee:-</b>The candidates attending for on-line counseling have to pay counseling fee of <b>Rs.7080/-</b> by way of D.D. drawn in favour of the Registrar, Dr.NTR UHS, payable at Vijayawada while attending for the counseling. If already paid produce the receipt.</p> <p><b>Under any circumstances the Registration Fee and Counseling fee once paid will not be refunded.</b></p>
