This Notification is issued for conducting of MD (Homoeo) Part-I & II Examinations in November/December,2019. Theory Examinations will commence from 12.11.2019 .

The following candidates are eligible to appear for Examinations.

MD (Homoeo) Part-I

1. The candidates admitted prior to 2017-18 who have appeared for Part-I MD (Homoeo) Examinations held in May, 2019 (or) prior examinations and failed in the said examinations, are eligible to appear for MD (Homoeo) Examinations in November/December'2019. These candidates are eligible to apply for all the failed subjects.
2. A Candidate not passing examination in a subject of Part-I M.D(H) Course shall reappear in all parts of that subject but only **ONE CHANCE TO REAPPEAR IN THAT SUBJECT OF EXAMINATION SHALL BE PROVIDED FAILING WHICH HAS TO REAPPEAR IN EXAMINATION IN ALL SUBJECTS (IN ALL PARTS) OF M.D(H) PART-I.**

MD (Homoeo) Part-II

1. The candidates who have completed 3 Academic Years of study period and passed all the subjects of MD (Homoeo) Part-I are eligible to apply for appearing MD (Homoeo) Part-II Examination.
2. The candidates should have minimum 80% of attendance .
3. These candidates shall enclose a copy of Part-I Marks Memos.
4. These candidates should have submitted dissertations within the time schedule fixed by the University as already notified.

Note: Hall Tickets to the candidates for MD(H) Part- II will be issued only if their dissertations are approved.

The fee is to be paid in the form of a crossed DD drawn from any Scheduled Bank, in favour of **THE REGISTRAR, Dr. NTR UNIVERSITY OF HEALTH SCIENCES**, payable at VIJAYAWADA. A consolidated DD may also be sent by the Principal, for convenience.

The following copies of certificates shall be enclosed by the candidates appearing for the MD(Homoeo) Part-I & II Examinations.

- a) Evidence of the date of birth (SSC or its equivalent Examination Certificate) attested Xerox copy only.
- b) Copy of BHMS Degree Certificates (Attested Xerox copy only).
- c) The candidates who are from outside the state appearing for the University examination for the first time should submit their migration certificate.
- d) Attendance certificate in the prescribed proforma and testimonials from 2 faculty members.
- e) Part-I failed candidates & P-II appearing candidates shall enclose copy of Part-I Marks Memo.

The academic year of admission, date of admission and particulars of previous appearance, if any, shall be noted in the application.

The Principals of the concerned colleges shall check the applications whether they are in Order and all columns are filled up by the student with required information and send them to the University with their Counter signature on the applications to reach within due dates.

Digital Valuation of answer scripts will be implemented for MD(H) Examinations from October/November, 2019 onwards.

In view of introduction of Digital Valuation, a single 68 pages OMR answer book with 64 writable pages will be issued to the candidates. The candidates should answer all the questions in the single answer book of 64 writable pages only.
