NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-III / FINAL PHASE OF COUNSELING TO FILL THE VACANT MANAGEMENT QUOTA SEATS IN POST GRADUATE MEDICAL DEGREE/DIPLOMA COURSES IN PRIVATE NON-MINORITY MEDICAL COLLEGES IN THE STATE OF ANDHRA PRADESH FOR THE ACADEMIC YEAR 2019-20.

In continuation to earlier notifications, the University hereby notifies the following schedule for **PHASE-III/FINAL PHASE** of Web counseling to fill up vacant seats under Management Quota (i.e., Unfilled seats after Phase-II vacancies due to not-joined, seats received from MCI and also the vacancies that may arise due to sliding of candidates during the process of this final Phase) of PG Medical Degree / Diploma courses in Private Non-Minority Medical Colleges in the State of Andhra Pradesh:

All the candidates whose names are in the Merit Position under MQ seats already displayed in the University Website are eligible for exercising web options.

However, candidates who have already joined in All India Quota Counseling in any State and for the seats in Deemed Universities are not eligible to exercise web-options. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.

Those candidates who were allotted a seat in the Phase-II and joined in the allotted seat are also eligible to exercise web options as per the above schedule, for sliding to any specialty / college as per their choice.

The candidates who have been allotted seats & not reported in the Phase II counseling are not eligible to exercise options for the same category, same college & same course / specialty (i.e., the seat allotted in Phase-II). But they can fill their options only for upgrading and they should join compulsory in the allotted seat.

The seats unfilled in the Phase-II of counseling, vacancies due to non-reporting of the candidates selected in the Phase-II of counseling and resultant vacancies if any arise due to sliding of candidates during the process of this Phase of counseling will also be filled simultaneously. The vacancy position is displayed in the University website.

INSTRUCTIONS TO CANDIDATES

1. Candidates who have joined either in Phase-II or in this final phase should not withdraw from the seat from now onwards under any circumstances.

If any candidate who has been allotted a seat but not reported in this Phase of counseling will not be permitted to participate in the MOP UP Round. Candidates who have joined in this Phase are also not eligible to participate in MOP UP Round.

2. The candidates who secured admission in the I & II phase of counseling and wish to change their college/course according to their merit, can exercise their web options. Candidates are informed that, once PG seat is allotted in this phase of counseling as per their web options, the seat allotted in the earlier Phase-II of counseling is automatically cancelled and re-allotted to other candidate in this phase.
3. A candidate can exercise options for any number of specialties irrespective of the number of vacancies. Candidates are advised to be careful while exercising options on the Web and take the print out of the saved options.
4. Candidates are advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies shown in seat matrix. Candidates are advised to give options to the courses for which they are really interested to join, so as to give chance to next meritorious candidates.
5. Candidate can download the provisional allotment order on payment of University fee of Rs.49,500/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order failing which the candidate will lose the admission. Candidates who have already paid the University fee in earlier Phases need not pay again.
6. Candidate can give options on the web either from home or any other place having internet facility. One Time Password will be sent to the registered mobile at the time of saving Web options. The password consists of SIX letter code with English capitals A to Z.
7. Candidates who were allotted a seat in Phase-II of Management Quota seats/ Competent Authority Quota seats in any college of AP and joined but slid to another college in AP in this Phase-III, should submit the tuition fee receipt along with relief letter issued by earlier college at the newly allotted college. The first college where the candidate initially joined will transfer the tuition fee and Original certificates etc., to subsequently allotted college in AP.
