Applications are invited from the eligible candidates for the post of "Director (Publications)" in Dr. NTR University of Health Sciences, Vijayawada on deputation basis on usual terms and conditions of foreign service as per G.O.(P) No.10 Finance & Planning (FW.FR-II) Dept., dated 22.01.1993 and its amendments.

Eligibility

1. Must be a Post Graduate in Medical / Dental / AYUSH Courses.
2. He / She should be an academician with teaching experience as Professor in an affiliated college of Dr. NTR UHS for not less than 3 years. (as on the date of notification)
3. Must have at least five publications as first / second author in indexed journals.

Age: Should not be more than 60 years (as on the date of Notification).

Scale of Pay: ₹ 37,400 – 67,000 (UGC 2006) as amended from time to time.

Experience Required / Desirable:

1. Experience in organizing at least two workshops in Research Methodology sponsored by NTR University of Health Sciences.
2. Ph. D. / Superspecialty in Medical / Dental / AYUSH as guide of not less than three students.

The other terms and conditions of the service of the **Director (Publications)** will be as decided by the Executive Council from time to time.

II) NOTE:

1. Professors working in the affiliated Government colleges of Medical, Dental & AYUSH courses with good track record and without any allegations are eligible to apply for the post of Director (Publications) through proper channel forwarded by the Director / Commissioner concerned.
2. The tenure of appointment is for one year initially and extendable yearly depending on the performance.
3. Applicant should affix one recent passport size photograph on the application.
