NOTIFICATION FOR EXERCISING WEB OPTIONS FOR PHASE-I OF COUNSELLING FOR ADMISSIONS INTO THE MANAGEMENT QUOTA SEATS IN POST GRADUATE DENTAL DEGREE/DIPLOMA COURSES IN PRIVATE DENTAL COLLEGES AFFILIATED TO Dr. NTR UHS IN THE STATE OF ANDHRA PRADESH FOR THE ACADEMIC YEAR 2021-22.

In continuation to this Office notification dt. 20-10-2021, Dr.NTR UHS, Vijayawada hereby notifies the schedule for exercising Web Options for 1<sup>st</sup> phase of counselling for admissions into Management Quota seats of PG Dental Degree/Diploma courses under Dr. NTR UHS for the academic year 2021-22:

## **SCHEDULE**

All the candidates whose names are in the Final Merit Position in the University Website are only eligible to exercise web options on the above schedule dates as per the Seat Matrix displayed in the website http://ntruhs.ap.nic.in

UNIVERSITY FEE: Candidates to whom allotment message given have to pay Rs. 49,500/- for obtaining allotment letter through payment Gateway by using Online payment method. (Debit Card /Credit Card /Internet Banking).

TUITION FEE: As per G.O.Ms.No.56, HM&FW (C1) Dept., dt. 29-05-2020 subject to the final Orders of Hon'ble High Court of AP against cases filed in various Writ Petitions:

Note: a) The fee structure in Private Unaided Non-Minority Colleges is as per G.O.Ms.No.56, HM&FW (C1) Dept., Dt.29-05.2020 as per the directions of the Hon'ble High Court in W.P.No.10159 of 2020 and batch, dt.09-07-2020, which is read as "to permit the petitioners/students to pay fee fixed by the Regulatory authority by executing bond in the proforma prescribed by the Andhra Pradesh Private Medical and Dental Colleges Managements Association within the specified time as notified by Dr. NTR University of Health Sciences, Vijayawada".

b) As per the directions of Hon'ble High Court in W.P.No.21389 of 2021, dt.01-10-2021 "to pay the stipend being paid by the dental colleges under G.O.Ms.No.75 Health, Medical and Family Welfare (C1) Department, dated 06-05-2017 pending further orders".

## <u>Instructions to Candidates:</u>

1. Candidate can give options on the web either from home or any other place having internet facility

One Time Password will be sent to the registered mobile at the time of saving Web options.

The password consists of SIX letter code with English capitals A to Z.

- **Note:** 1. If any candidate does not join the allotted seat in this Phase-I of Management Quota counselling will not be permitted to participate in the next Phases of Counselling.
  - 2. Candidates who have already joined in All India Quota counselling in any state and also for the seats in Deemed Universities are not eligible to exercise web options. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.
- 2. The detailed instructions for entering options on web are available at https://apmdsntruhs.com/MDS/Management/Signup
- 3. Seat Matrix is displayed in the University Website for the information of the students to exercise web options. A candidate can exercise any number of options.
- 4. Candidates are instructed to be careful while exercising options on the Web and take the print out of the saved options.
- 5. Candidate can download the provisional allotment order on payment of University Fee through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order.
- 6. Next rounds of counseling (exercising web options) will be conducted for:
  - a. Left over seats in Phase-I
  - b. Not reported/Not joined seats.
- 7. Selected candidates have to report at the respective colleges on the dates specified on the allotment letter with all Original certificates, necessary bond(s) and pay the tuition fee to the college and complete the admission process. If the candidate slides to other college (i.e., affiliated colleges of Dr.NTR UHS) during subsequent Phases of counselling, the original certificates will be sent to the college concerned by the college where the candidate has slide.
- 8. The University fee of Rs.49,500/- once paid shall not be refunded under any circumstances.
- 9. If any candidate already joined in a seat under Competent Authority Quota seat in AP State can slide to a seat under Management Quota seat in AP State and in such case, the tuition fee already paid for the Competent Authority Quota will be returned to the candidate by the concerned college.

Note: The above provisions of sliding are restricted to AP State only.
