NOTIFICATION FOR EXERCISING WEB OPTIONS FOR Phase-IV (Final Phase) OF COUNSELING FOR THE VACANT SEATS OF **POST-GRADUATE MEDICAL DEGREE / DIPLOMA COURSES** UNDER Dr. NTR UHS AND SVIMS, TIRUPATI FOR THE ACADEMIC YEAR 2019-20.

Dr.NTR UHS hereby notifies the following schedule for Phase-IV (Final Phase) of Web counseling to fill up the vacant Competent Authority Quota seats i.e., Unfilled seats, Not joined vacant seats after Phase-III of web counseling and also the vacancies that may arise due to sliding of candidates during process of this Phase-IV (Final Phase) of PG Medical Degree/Diploma courses under Dr.NTR UHS and SVIMS, Tirupati.

Note: 1. The PG Medical seats released due to dismissal of Court cases are also included in this Phase-IV.

2. Few newly added PG Diploma seats are also included in this Phase-IV.

This notification is issued for PG Medical Degree/Diploma courses only.

1. All the candidates whose names are displayed in the University website and notified in the Merit Position on 05-04-2019 are eligible for exercising web options.
2. **However, candidates who have already joined in All India Quota Counseling in any state and for the seats in Deemed Universities are not eligible to exercise web-options. If any candidate violates this and noticed by the University at any stage then the candidate is liable for punishment and his/her admission will automatically stands cancelled.**
3. Those candidates who were allotted a seat in the Phases-I, II & III and joined/not reported in the allotted seat shall also exercise web options as per the above schedule, for sliding to any Specialty/College as per their choice in view of availability of seats in Clinical Specialties after Phase-III.
4. Resultant vacancies if any arise due to sliding of candidates during the process of this Phase of counseling will also be filled simultaneously.
5. The vacancy position will be displayed in the University website on 07-05-2019.

The remaining seats if any, will be converted and allotted in this phase as per GO MS No.68, HM & FW (C1) Dept, Government of Andhra Pradesh. dt. 21-04-2017.

INSTRUCTIONS TO CANDIDATES

1. Candidates who have exercised options, allotted a seat and joined the course in this Phase shall not be permitted to leave the seat.
2. A candidate who exercised options and joined in an allotted seat in this Phase-IV (Final Phase) shall not be permitted to withdraw from the seat. In case any candidate withdraws from the joined seat, the candidate shall be debarred for a period of three years for admission into Post Graduate Medical Degree/Diploma courses at the colleges in the State of Andhra Pradesh besides payment of Rs. 3 lakhs.
3. Candidates who have joined either in earlier Phases of counseling or in this Phase-IV (Final Phase) should not withdraw from the seat.
4. If any candidate who has been allotted a seat but not reported in this Phase of counseling will not be permitted to participate in the MOP UP Round. Candidates who were admitted in the colleges are also not eligible to participate in the MOP UP Round.

5. The candidates who secured admission in the Phases- I, II & III and wish to change their college/course according to their merit, can exercise their web options. Candidates are informed that, once PG seat is allotted in this Phase- IV as per their web options, the seat allotted in the earlier Phases of counseling is automatically cancelled and re-allotted to other candidates in this Phase-IV.
6. List of vacancies available will be displayed in the Website for information of the students to exercise web options. A candidate can exercise options for any number of specialties. Candidates are advised to be careful while exercising options on the Web and take the print out of the saved options.
7. Candidates while giving options should note that the seats vacated by the candidates selected in previous counseling and slided to other college/course during this phase of counseling process will be added & allotted simultaneously during this Phase of counseling itself.

The candidates are therefore advised to exercise options for all the seats in all the colleges as per their priority irrespective of vacancies shown in seat matrix. Candidates are advised to give options to the courses for which they are really interested to join, so as to give chance to next meritorious candidates.

8. Candidates who were allotted a seat in any college of AP and joined, slided to another college in AP in subsequent counseling, should submit the tuition fee receipt along with relief letter issued by earlier college, for admission at the newly allotted college. The first college where the candidate initially joined will transfer the fee to the respective college/refund to the candidate and also send all original certificates to subsequently allotted college in AP.
9. Candidate can give options on the web either from home or any other place having internet facility with Internet explorer 11 version. One Time Password will be sent to the registered mobile at the time of saving Web options. The password consists of SIX letter code with English capitals A to Z.

10. Candidate can download the provisional allotment order on payment of University fee of Rs.23,500/- through payment gateway and report to the Principal of the Allotted College on or before the date specified in the allotment order failing which the candidate will lose the admission. Candidates who have already paid the University fee need not pay again.
11. The University fee once paid shall not be refunded under any circumstances.
